Dear Investor:

SkyBridge Multi-Adviser Hedge Fund Portfolios LLC - Series G ("Series G") generated an estimated 1.58% net return in July and an estimated 8.35% since April 1. Full year performance data for 2020 and prior periods is located on pages five and six of this letter. The three largest contributors to July's performance — representing approximately half of July's return - were Linden (convertible arbitrage), Third Point Ultra (multistrategy), and Point72 (hedged equity). These managers also diversify Series G's portfolio and enhance downside protection. Notably, two of the managers were added to the portfolio in the second quarter.

After a strong June, structured credit consolidated recent gains. Absent price appreciation, July's return contribution came primarily in the form of cash flow. Series G's structured credit positions trade at substantial discounts to par, and, based on our credit analysis, we are confident in the reliability of the cash flows. As a consequence, we believe structured credit represents real value, particularly in comparison to other asset classes

Over the next six to twelve months, we believe structured credit price appreciation will be driven by inflows into the sector. As an example, KKR and Canyon announced last month that they are raising dedicated structured credit funds

Our recent tender offer ended on July 24th. As always, we will be redeeming all Series G investors in full. Moreover, we expect Series G's portfolio to retain substantial portfolio continuity. As an example, the top five managers are anticipated to remain unchanged, and eight of the top ten managers should remain the same. Further, credit strategies (i.e. structured credit and distressed corporate credit) presently represent 72% of the portfolio. On October 1st, credit strategies are expected to represent 73% of the portfolio.

Given the above and based on recent conversations with financial advisors, we expect substantial rescissions of redemptions this quarter. For your convenience, attached is rescission paperwork.

There were no changes in the investment process or strategy following the change in the Fund's Investment Manager.
